Form Purpose	Use this form to document a tax-year contribution to your IRA account.

	We are available 9:00 a.m. to 5:00 p.m. MT, Monday through Friday.					
Instructions	A Deposit Slip: IRA Contribution and a deposit of funds are required to record an IRA contribution.					
	Funds may be deposited by check, ACH, or wire.					
	Include the deposit slip with a mailed check.					
	Send the deposit slip using the delivery instructions below if funds are deposited by ACH or wire.					
Fees	The following fees may apply to this transaction:					
	\$15.00 Inbound wire fee.					
	Fees will be debited from the IRA.					
	You may choose to add \$15.00 to your contribution account if funds are deposited by wire.					
	Please refer to the current Fortis Bank IRA Custodial Fee Schedule for details.					
Timelines	Funds are typically available within 1 business day of receipt of both cash and the deposit slip.					
Important Notes	Please consult with a competent tax, legal, or investment advisor to determine if you are eligible to contribute to an IRA, how much you can contribute, and whether your contribution may be tax deductible.					
	All IRA contributions must be made in cash.					
	For IRA LLC and IRA Trust plans offering checkbook control:					
	Never make an IRA contribution directly to the LLC/Trust checking account. The contribution must occur through the IRA account.					
	If your account has been established with auto-funding (default), Fortis Bank will automatically invest newly contributed cash into the LLC or Trust.					
	If your account requires manual entity funding – such as if the IRA holds more than one LLC/Trust – you will need to submit a <i>Buy Direction</i> form instructing Fortis Bank to invest cash from the IRA to the entity.
