

## **IRA Transfer Instructions**

Form Purpose	Use this form to request a direct transfer of cash and/or assets from another IRA custodian to your Fortis Bank IRA account.

Instructions	<ul> <li>Before You Submit This Form:</li> <li>Liquidate any non-cash assets that are not being transferred in-kind. Fortis Bank cannot accept publicly traded securities.</li> <li>Confirm with your current IRA custodian whether an ink-signed original or medallion signature guarantee are required, or if a certified digital signature is acceptable.</li> </ul>
Fees	The following fees may apply to this transaction: \$15.00 Inbound wire fee. \$75.00 Re-registration of non-cash asset in-kind.  Fees will be debited from the IRA. Please refer to the current Fortis Bank IRA Custodial Fee Schedule for details.
Timelines	Transfers of cash can take from 5 to 30 business days, depending on the responsiveness of the current custodian.  Transfers of assets-in-kind may take from 2 to 10 weeks.
Important Notes	IRA transfers must be initiated by the receiving custodian (Fortis Bank).  An IRA-to-IRA transfer is non-taxable and may include cash or non-traditional assets inkind like real estate or non-public stock. Fortis Bank cannot accept the transfer of publicly traded securities.  Transfers must be between accounts with the same tax-type, such as Roth to Roth or Traditional to Traditional. The account owner must also be the same on both accounts, except for transfers to an ex-spouse per a divorce decree. You may transfer an inherited IRA, so long as the receiving account is also an inherited IRA with the same original account owner.  Do not use this form to request a rollover from a Qualified Employer Plan. Initiate a rollover request with your current plan administrator and submit a <i>Rollover Certification</i> form to document the deposit to your Fortis Bank IRA.
